

**Web Ballot
General Election
Chelan County, Washington
November 3, 2009**

This is a special absentee ballot designed for military, overseas or voters who are unable to vote a regular ballot in a timely manner.

PLEASE READ ALL DIRECTIONS BEFORE VOTING YOUR BALLOT

Step 1: Print the ballot and oath.

Step 2: Vote your ballot by following the instructions printed on the ballot.

Step 3: Sign the oath.

Step 4: Place the oath and ballot in an envelope and address to:

Optional: To keep voter secrecy separate the oath and your signature from the ballot itself. Place the voted ballot in a plain envelope. Place the oath and the plain envelope into a larger envelope and address the outer envelope.

Step 5: Place adequate postage on your envelope and mail. The envelope must be post marked by Election Day, November 3rd for your ballot to be counted.

IMPORTANT: If you are unable to get an Election Day post mark, fax or email your ballot by November 3rd, Election Day. The original ballot and your signature must be received by mail in our office by November 23rd; otherwise your fax or email ballot will not be counted.

Note: Your vote for a special election in districts, for which you are not qualified to vote, will not be counted.

If you are a resident of Chelan County and not a registered voter, you may still be eligible to vote. You must be a member of the uniformed services or merchant marine on active duty, or an eligible spouse or dependent; a U.S. Citizen residing outside the U.S. temporarily; or a U.S. Citizen residing outside the U.S. indefinitely. VOTER'S OATH

The voter agrees to waive the secrecy of his or her ballot (WAC434-208-060) when returning a faxed or emailed ballot.

I do solemnly swear or affirm under penalty of perjury that: I am a citizen of the United States; I am a legal resident of the state of Washington; I will be at least 18 years old on or before election day; I am not presently denied my voting rights as a result of being convicted of a felony; I have not been judicially declared mentally incompetent; I have not already voted in this election; and I understand it is illegal to cast a ballot or sign a ballot envelope on behalf of another voter. Attempting to vote when not qualified, attempting to vote more than once, or falsely signing this oath is a felony punishable by a maximum imprisonment of five years, a maximum fine of \$10,000, or both.
