ELIGIBILITY - You are eligible to vote if you are a citizen who will be 18 by Election Day. You must be registered in order to vote. You can register at any time up until thirty (30) days before an election. The only exception is for in-person registration at the Auditor's Office, which can be done up to 15 days before an election. (First time and out of state only)
 HOW TO REGISTER - In person at the County Administration Building (Auditor's Office), or State Department of Driver Licensing. Mail-In Voter Registration forms may also be obtained at various registration locations.
 ELECTION DATES- **Primary Elections** shall be held on the third Tuesday of August. **General Elections** shall be held on the first Tuesday after the first Monday in November. Federal, State, and County officials are chosen in EVEN years; city and district officials are chosen in ODD years. State ballot issues are submitted to voters at the **General Election**. Local school or municipal proposals may be submitted at specified times; sometimes a **Special Election** is called for this purpose.
